## 2018-2019

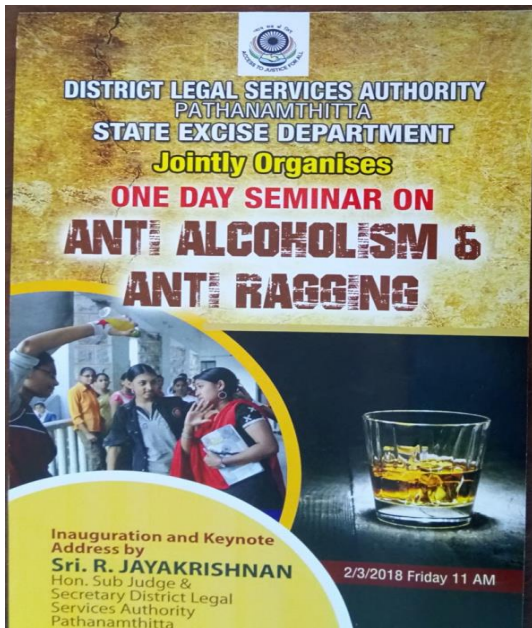
